WHAT IS DIGITAL IDENTITY?

It can include:

- Multi-factor authentication (MFA)
- Biometric logins
- Secure ID cards or mobile access apps

In community care, where staff may move between houses or shift locations, digital identity ensures access is both fast and safe.



WHY IT MATTERS IN THE NDIS SECTOR

Without proper identity controls, systems can be accessed by the wrong person or the right person in the wrong way.

For Thrive and similar providers, secure access helps:

- Keep participant data private and protected
- Control physical entry to homes or sensitive systems
- Ensure accountability for actions taken in digital systems
- Avoid delays caused by forgotten logins or manual approvals

It's about trust in the system, the process, and the people behind the screens.






MICROSOFT'S ROLE IN IDENTY SECURITY
